CHAPTER FOUR

Richard Nichols and Descendants

Generation No. 2

1. RICHARD³ NICHOLS (*JOHN*², *UNKNOWN*¹) was born 1799 in Amherst County, Virginia, and died bet. February 24 - June 01, 1830 in Barren County, Kentucky. He married **MARGARET FRANCES** "**PEGGY" BURCH** October 08, 1822 in Barren County, Kentucky, daughter of JOHN BURCH and ELIZABETH BENHAM. She was born January 21, 1799 in Fauquier County, Virginia, and died June 01, 1858 in Marion County, Iowa.

Notes for RICHARD NICHOLS:

Only limited information is available in the public record about Richard Nichols, the third child of John and Nancy Nichols. According to various reports, he was born in the year 1799, which, if true, would place his birth in Amherst County, Virginia. He would have been about 11 or 12 years old when his family finally settled in Barren County, Kentucky. Because he died so young, at approximately 31 years old, he never appeared as "head of the household" in U.S. Census reports. In 1820, he was still a single man and was carried as a member of his father's household, and although he married in 1822, his death occurred before the census was enumerated on June 1, 1830. However, he was still living on February 24, 1830, as demonstrated by the land deed outlined below, so his death must have occurred between February 24 and June 1, 1830.

On October 8, 1822, Richard Nichols married his mother's first cousin in Barren County. She was Margaret "Peggy" Burch, the daughter of John Burch, who was an uncle of Nancy Burch Nichols. Both the groom and bride were 23 years old at the time. The close ties that existed between the Nichols and Burch families at the time are best exemplified by the fact that three children of John and Nancy Nichols married three children of John and Elizabeth Burch. In addition to Richard and Peggy, Ann Nichols married Robert Benham Burch, and Phillip Nichols married Frances "Fanny" Burch.

On December 25, 1823, Joseph Willis issued a note in bond, agreeing to sell to Richard Nichols a certain 100 acre tract of land, located in Barren County, for the sum of \$300 of which the last payment was due from Nichols on December 25, 1827. The tract was described as the lower part of a tract originally containing 200 acres taken as "head right" land by John West. However, Joseph Willis died before he could make a deed to Richard Nichols, and Richard Nichols had to petition the Barren County Court to direct the commissioner to convey a deed to him from the infant heirs of Joseph Willis. In an indenture dated February 24, 1830, the heirs of Joseph Willis, through commissioners appointed by the Barren County Court, issued a deed to Richard Nichols for the 100 acres. (Deed Book L, page 618, Barren County Clerk's Office.) After the death of Richard Nichols, ownership of the 100 acre tract, which was located on Fallen Timber Creek, remained with his widow and two children until 1849, when a third of the tract was sold to Philip Burch. (Deed Book T, page 545.)

It is believed that Richard and Peggy Nichols named their son, Joseph Willis Nichols, after their neighbor, Joseph Willis, the same man who sold Richard Nichols his land in the transaction mentioned above. According to Clayton Simmons' book, "A Historical Trip Through Barren County, Kentucky," Joseph Willis and his wife, Sally Twyman Garnett, came to Barren County

from Virginia early in the 19th century and established their home near Fallen Timber Creek in 1812. That was also about the same time that John Nichols and his family settled on Fallen Timber Creek, and it's possible that the two men knew each other from their time in Mercer County and then traveled to Barren together. There was an individual named Joseph Willis listed on the 1810 Mercer County census. Evidently, Mr. Willis was a man of considerable means and at one time owned some 750 acres of land on or near Fallen Timber Creek. As mentioned above, Joseph Willis died sometime prior to February 24, 1830, and after his death, his wife, Sally, lived on the property for many years.

The circumstances of Richard Nichols' death are not known, but after his death, his father, John Nichols, was appointed by the Barren County Court as the administrator for his estate. A "Sale Bill," was recorded on November 12, 1830, listing the disposition of his personal property which was sold at public auction as ordered by the court. The inventory included the following items: One sorrel colt, one gray colt, one black mare, several cattle, three calves, including one bull calf, many hogs, six head of sheep, one rifle gun and apparatus, one man's saddle, and approximately 30 barrels of corn. Most of the furniture was purchased by Peggy Nichols, Richard's widow, and included two bedsteads and furniture, one press, eight chairs, one loom, one square table, and two ovens. She also purchased three choice hogs, seven choice shoats, two cows and one singletree plow and gear. The total amount raised by the sale was \$180.94, and Peggy Nichols' share of that amount was \$60.31. It was not until 16 years later that the final settlement was made and accepted by the court on April 1, 1846. (Inventory of Property, 1831-1835, page 104, Barren County Circuit Court.)

Richard Nichols was almost certainly buried in the Nichols family cemetery (now called Bowles family cemetery) located just off the Vernon School Road and not far from the John Nichols home place in Barren County. His grave would have been located in what is now the older part of the cemetery, although no stone exists today to show its exact location.

Burial: Bowles Cemetery, Barren County, Kentucky

Notes for MARGARET FRANCES "PEGGY" BURCH:

Margaret "Peggy" Nichols became a widow at 30 years of age when her husband died in the early part of 1830. At the time, she had been married for almost 8 years and had two children. When her deceased husband's property was sold at public auction, she was able to purchase back most of the family's furniture as well as two cows and several hogs and shoats. She would continue to reside in their home in Barren County, Kentucky for the next 20 years, until near 1850.

On November 1, 1849, Margaret F. Nichols, along with her children, Joseph Willis Nichols and Sophronia Nichols Pursley, sold one third of their 100 acre tract (33 and 1/3 acres) located on the waters of Fallen Timber Creek, to her nephew, Philip H. Burch for the sum of \$50.00 cash-in-hand. The land parcel was part of the original 100 acre tract purchased by Richard Nichols in 1823 and deeded to him on February 24, 1830. (Deed Book T, page 545.)

The 1850 census for Barren County, Kentucky showed Peggy Nichols living in the home of her daughter, Sophronia Nichols Pursley. Listed are Joseph T. Pursley, age 34, a farmer and head of the household, his wife, Sophronia, age 27, Jehu, age 2, Nancy M., age 1 month, and Martha F. Nichols, age 55. (The first name is listed incorrectly in the census report and should have been "Margaret" F. Nichols instead of Martha.)

In an indenture dated April 5, 1855, Margaret F. Nichols agreed to sell her interest in the remaining 66 and two thirds acres, located on Fallen Timber Creek, to her son-in-law, Joseph T. Pursley, for the sum of \$140, of which \$40 was paid cash-in-hand and the remainder due in three notes of \$33.33 each. (Deed Book X, page 26, Barren County Clerk's Office.) It seems clear that by early 1855, the decision had been made to leave Kentucky and relocate in Iowa.

Sometime after April of 1855, Peggy Burch Nichols, then about 56 years old, departed Barren County, Kentucky, along with her son, Joseph W. Nichols and his family, and relocated to Marion County, Iowa, where many of her Burch relatives had settled several years earlier. Among Peggy's kinfolk already living in Iowa were her sister, Fanny Burch Nichols, the widow of Phillip Nichols, who had moved to Marion County, Iowa with her children in the mid part of 1852, and her brother, Robert B. Burch, who moved there in mid-1853. Peggy's daughter, Sophronia Pursley, who was married and had several children, remained in Barren County. Peggy Nichols died in Marion County, Iowa on June 1, 1858 at the age of 59 years old and is buried on the old Burch farm in Union Township.

More About MARGARET FRANCES "PEGGY" BURCH:

2. JOSEPH WILLIS⁴ NICHOLS (*RICHARD*³, *JOHN*², *UNKNOWN*¹) was born June 06, 1822 in Barren County, Kentucky, and died November 12, 1864 in Little Rock, Arkansas. He married **SARAH ANN PURSLEY** June 24, 1847 in Barren County, Kentucky, daughter of WILLIAM PURSLEY and MARY BUCKLEY. She was born September 22, 1824 in Barren County, Kentucky, and died May 19, 1908 at the home of her daughter, Mary, in Salida, Colorado.

Notes for JOSEPH WILLIS NICHOLS:

The 1850 U.S. Census for Barren County, Kentucky listed Joseph Nichols, age 26, a farmer and head of the household, his wife, Sally, age 29, and a daughter, Ursula M., age 1. (Note: The ages are reversed on the census report as Joseph was two years older that Sarah).

On November 1, 1849, Joseph Nichols, with his mother and sister, all agreed to sell one third of their 100 acre tract, located on Fallen Timber Creek, to their uncle, Phillip Burch. A tract containing 33 and one third acres was sold for \$50 cash-in-hand, being a part of the 100 acre tract deeded to Richard Nichols on February 24, 1830. (Deed Book T, page 545.) Six years later, on March 20, 1855, Joseph W. Nichols and his wife, Sarah A. Nichols, sold their interest in the remaining 67 acres to his brother-in-law, Joseph T. Pursley, for the sum of \$150. (Deed Book X, page 25, Barren County Clerk's Office.) Shortly after April of 1855, Joseph Nichols left Barren County with his family, including his mother, and moved west to Marion County, Iowa, where his Burch relatives had settled previously.

Joseph W. Nichols was a Civil War veteran, Union Army, Company "A," of the Thirty Third Iowa Infantry. He enlisted on August 15, 1862 at the age of 39 years old, and was mustered into service on September 9, 1862. At the time of his enlistment, he gave his home as Knoxville, Marion County, Iowa. He fought in numerous battles and skirmishes in Arkansas including the failed Red River Campaign.

In the spring of 1864, three Civil War battles took place in south central Arkansas. These battles were part of the Union Army's "Red River Campaign." The first battle occurred at Poison Springs on April 17-18, ten miles from Camden, where Confederate troops captured a Union supply train and scattered their forces. On April 25, at Mark's Mill, Confederate troops captured another supply train. With the loss of two supply trains and the onslaught of the wet spring weather, Union forces commanded by General Frederick Steele, were forced to retreat from Camden toward Little Rock. The third battle took place near Jenkins Ferry. On April 26-30, Steele's troops fought off a rear attack by the Confederates and crossed the flooded Saline River via a pontoon bridge. From there, the ragged Union forces retreated back to Little Rock.

Joseph W. Nichols died of dysentery on November 12, 1864, while stationed at Camp Bridge in Little Rock, Arkansas, and he is buried there in the National Cemetery, Section 2, Grave No. 222. (Note: He was not a Confederate prisoner of war as has been reported by some sources). A great-granddaughter, Florence Reynolds, has in her possession, nine letters written by Joseph Nichols to his wife and family during the period he was stationed at Little Rock. The letters are dated between March and November of 1864, the last one written just four days before his death. In these letters he wrote about various aspects of his life as a soldier and often mentioned the names of his friends and kinfolk from Knoxville, Iowa who were serving in the same company with him. Following are selected excerpts taken from these letters:

Little Rock Ark. March 16, 1864

Dear wife and children

I set down this morning to write you a few lines in answer to yours of March 2nd and I was glad to her from home once more for it was one month since I left home and had not herd from you since I left. You wrote something about the sox. My sox is good enough and everything is good enough when a man is well. I am not well. I have the Mumps in both sides and am marked off of duty and am seting in my bunk writing you a few lines.

I have nothing of importance to write to you. You said that you had not got my money yet and I sent you sixty six dollars. I sent it to Wm. M. Norrice and when he gets it you will get it. And I sent my muster role to Wm. Lewty and he will give it to Bishop and he will pay my township bounty. You must go and see Mr. Norrice and if you can't find it I will send you the express receipt and then you can get it. I expressed my money on the 22nd. of February and I think you will get it in a few days.

Well Amanda I want you to be smart and learn your book and be a good girl and mind your mother and raise lots of potatoes and onions for to roast. Well Selborn, you must cut wood and make good fires and be a good boy. Samuel you must hunt some eggs and pick up chips and be a good boy. Mary you must whip Pugh and make him cry. I sent you five cents in a leter that I sent to Uncle John James and I will send fifty cents in this and that will be ten cents to each of you.

I will quit for this time. Write soon and often. You wanted me to number my letters. I do not know how many I have wrote so this is number one. Write soon and often.

When Joseph W. Nichols enlisted in the Union Army, he left his wife, Sally, and four young children back at home on their farm in Iowa. At the time these letters were written the children's approximate ages were: Amanda 11, Selborn, 8, Samuel, 5 and Mary, 2.

Camp of 33rd Iowa May 4th, 1864

Well as it has bin some time since I had a chance to write to you I will try and write you a few lines. We have been out on a march. We started the 23rd of March and we got in yesterday the third of May and we had a hard trip of it for we had to fight sixteen days on the trip and my feet is worne out tel I cant get round to have fun. I am well as to health. My health is as good as could be.

I got a leter from you yesterday and was glad to hear that you was well. Well you said that you had not got my money yet. I sent my money to Pelly and you can get it when you go thar. It is ready for you. When you go you will have to give a receipt to who goes after it and Bishop says he left sixty five dollars for you at Wm. Norrice and I do not know when I will get any more money for I have not bin mustered for pay yet and I have not mutch.

I got a leter from Wm. Lewty that I was glad to see. Tel him to write often as he can. I got two when I was at Camden from you and one from Pugh and one from Lewty and I wrote one to you and started it to you and the train was taken and it went up the spout and I guess you will think it long betwix news.

I want you to send me some stamps in your leters for I have not got any and I have to barrow one to sent this and I have bin on the barrow for some time and I am afraid that my friends will not lend if I dont pay before long. I want you to write as often as you can and tel the rest to write to me. So no more this time. So farwell to all at home.

The "march" referred to by Joseph in the letter above was part of the ill-fated Red River Campaign which was an attempt by the Union Army to combine a large naval / military force and capture Shreveport, Louisiana. As part of the plan, Maj. Gen. Frederick Steele was to proceed south from Little Rock with 15,000 men and join the main Union force before the attack on Shreveport. Unfortunately, Maj. Gen. Nathaniel Banks and his force was defeated at Mansfield (40 miles south of Shreveport) by 8000 Confederate troops commanded by Maj. Gen. Richard Taylor, which effectively ended the campaign. The Union gunboat fleet under Adm. David Porter, comprised of 12 ironclads, was almost stranded because of an abnormally low water level in the Red River and barely managed to pass over the rapids and escape. Meanwhile, Steele's force from Little Rock was continually harassed by Confederate cavalry and guerrillas. Confederate troops captured two of his supply trains, and he was fortunate to finally get his ragged men back to Little Rock.

Little Rock Ark May 13th 1864

Dear wife and children

I set down to answer your leter whitch came to hand this morning and was red with mutch pleasure. I was glad to hear that you was well and doing well. I was sory to her that your wheat was all dead and that you had to plant it in corn tho I wish that you may do well in the corn crop for it will be beter than no crop.

Well it is raining today and I have nothing to do this time for I was on duty yesterday and Jo Foster was on picket last night and it rained like fun, and John was on camp gard in the rain, and O. D. was in his bunk, and his bunk is over mine, and we have a fine time in camp for we are all harty.

You said something about what I had to eat and I will say that we have plenty and have had ever since we came back, tho we was on short rations on the road. I did not eat as mutch on the road as a man aught to have in one day. Well, we have lots of bread and meet and coffee and some rice and some potatoes and some homony and sometimes pies when we by the fruit at thirty cents per pound. You must have some coffee, let it cost what it will. Have it for if I was thar I would have it and if your money runs out I will send you a few dollars.

Well you said something about general Steel. He is a tolerable good officer tho he is not as good a man as general Rice, for Rice is rite on the goose, and when his Brigade is on the field he is with them and the shells dont scear him. He was shot threw the ancle on the Saline and Colonel Mcvey was shot threw the arm

Amandy you must learn fast and write me a leter for it would do me lots of good to read a leter that you wrote. And Selborn you must learn five days and work one day and play one. And Samuel you must learn fast and when I come home then you can spell for me. Mary you must sing them songs that I sent to you and I will send you some in this and you must sing them all. So farwell for this time. Write soon and often. It is still raining.

The "general Rice" referred to in the above letter was Brig. Gen. Samuel Allen Rice, who organized the 33rd Iowa Infantry in Oskaloosa in 1862. He served under Maj. Gen. Frederick Steele, and at the Battle of Jenkins' Ferry, on April 30, 1864, while rushing to organize resistance on the Union left, he was badly wounded in the right ankle when a bullet struck his spur, driving fragments of it through his boot. He was sent home to Oskaloosa where he died in surgery on July 6, 1864.

Little Rock Ark May 26th, 1864

Dear wife

I have bin looking for a leter from you for a week and have not seen it yet and know I shall not look for one tel thar comes another from you for the rebs took a boat on White River last week and I guess our mail was on it. If it was old Shelby will read them and we will not know anything about what you are doing.

I am well as to health the I have the rheumatism in my shoulder so that I am not fit for duty today the my health is good. I have enjoyed the best of health this summer and if I was at home you would want me away for I am so mischieveous that you could not spend time in the same house.

O. D. Nichols is gone to the penitentary to gard the prisenors and J. Shilling is out on picket and J. B. Foster is lying in the bunk asleep. He is not well and I think he is a little home sick with something else.

Well that is some excitement in our camp. Some says that old Price is in thirty miles of here. He may be but I would like to see them, for hunting butternuts is the hardest hunting I ever done in my life, and now I want them to hunt me, and if they do we will give them some fun before they get us all. My old gun is in trim at all times.

I will send you my likeness when I get my pay. That is some talk of his coming next week. So no more this time. Write soon and often.

The three men mentioned above, O. D. Nichols, J. Shilling and J. B. Foster, were all kin to Joseph W. Nichols, either directly or by marriage. Ozias Denton Nichols, was a son of Phillip Nichols and Joseph's first cousin. John Shilling was married to Sophronia Nichols, O. D.'s sister. Joseph B. Foster was married to Mary Ellen Nichols, another sister of O. D. They were all from the Knoxville, Iowa area and had enlisted in the 33rd Iowa Infantry together.

Camp Bridge Little Rock Ark June 8th, 1864

Well your leter came this morning and was red with great pleasure, and I was glad to her that you was all well and doing well, and I was glad to her that your crop looked well, and I was glad to her that you had the good luck to get it plowed for I was afraid that you could not get your corn plowed. I want you to do the best you can for yourself and the children.

Well we have not got any pay yet tho the talk is that we will get our pay next Tuesday, and if we do I will send you my profile and some money. I will quit for this time and go to see Jasper M. Pugh for it is said that he is going to Memphis Tenn to his Regment. I was over that a few days ago and he was on detail to go on a boat and he was gone to Ft. Smith and he is back now.

Write soon and often and tel all of the neighbors to write to me and let me know how things are thar. Farwell.

Little Rock Ark September 13, 1864

Well I have set down to try and write you a few lines to let you know that I am with the company tho not stout enough for duty and hardley stout anuff to write to you tho I will try to do my own writing after this. Well Sally I will tell you that I have had a hard time in the hospital, and today I came out and I fel like a new pursen, and I hope my time will pass away and let me stay in good health is all that I can wish for in this armey, and then I will think I am lucky tho I will have to take it as it comes........

Although discharged from the hospital, it seems clear that Joseph had been seriously ill, probably with dysentery, and in this letter he appears to be cautiously optimistic about his recovery. It is a sobering fact that during the Civil War, over seven times the number of men died from disease and illness than were killed in battle.

Little Rock Ark September 20th 1864

Dear wife and children

I set myself down to write you a few lines to let you know that I am able to scrible a little yet tho I am not stout. I am with the company tho not fit for duty. I have had a hard time of it tho I think I will get

along if I can get anything that I can eat, tho I will have to by it and everything is so high that it takes a lot of money to get a little.

Well I will tel you something about maters. You said that you dident intend to pay that note that Mr. Pugh had. I want you to pay it for he has bin lots of help to me and if you get the money that I sent by Bishop. I sent fifty dollars all in one bill, and it was sent to Wm. M. Norrice, and I want you to write and let me her from you. It is getting so dark that I cant see any more and I will have to quit for this time. Write soon and often for it does me lots of good to read your leters. Farwell for this time.

Little Rock A. October 28th 1864

Dear wife and children

I seat myself to scrible you a few lines to let you know that I have not for got you yet and will not for I want to see you all very bad tho I cant come yet, and I do not know when I can til my time is out, for this is a hard place to get away from, and I will not leave without I can go right.

I am not as well as I was a few days ago. I have had the diareah, tho it is beter today. I have wrote to you to send me some buter and honey and you have not said anything about it yet. I want you to pay the express when you send it, and if you have anything else you can do as you please. You can send them cheaper than I can by them her, for I have to pay one dollar for buter and one dollar for honey and onions twenty five cents a pound, sweet potatoes two dollars a bushel, Irish potatoes four dollars, and everything about the same. I have no money to by with and that is why I sent to you for something to eat as thar has bin several boxes come to the company, and that was the cheapest for me.

Well I want you to write as often as you can and then I will write one or two leters every week. I have wrote two every week since I came from the hospital. Well I have not anything more for this time.

U.S. Christian Commission Soldier's Message November 8th 1864

Dear wife

I set down to try to write you a few lines to let you know that I am not as well as I have bin. I have had the diareah for the last day and night and it has run me down. It is beter today.

I have no news more than to say that our men has bin doing well so far as fighting. I think this war cant last long. I have bin to the election and gave old Abe a boost, and I hope he will get enough.

Well O. D. N. and J. S. and J. B. F. is all gone to Ft. Smith. They are all together and they will be gone four or five weeks. You may tel ther folk that they are gone and they do not know when they wil come back. So no more this time. Yours truly

Joseph W. Nichols

This was the last letter Joseph Nichols wrote to Sally before his death four days later of acute dysentery. A few days earlier, his company, which included his friends and kinfolk from Iowa,

had departed Little Rock for Ft. Smith, Arkansas, leaving him behind.

More About JOSEPH WILLIS NICHOLS:

Burial: National Cemetery, Little Rock, Arkansas, Section 2, Grave 222 Military service: Veteran of the Civil War, Union Army, served in Company A, 33rd Iowa Infantry

Notes for SARAH ANN PURSLEY:

According to family oral history, Sarah Pursley Nichols came from a family in Kentucky who were strong southern sympathizers. As a Civil War widow, Sarah felt that she could not return back to her own folks because her husband had fought (and died) on the Union side during the war. She remained in Iowa until the early 1870's when she took her family and moved to the state of Colorado.

In 1870, the census record for Marion County, Iowa showed the widow, Sarah Nichols, living on her farm with three of her children. The family included her son-in-law, John W. Immel, who had married Amanda, and a new grandchild. The census for Union Township listed J. W. Immel, age 20, a farmer, his wife, A., age 18, keeping house, and a son, C. A. C., age 2 months. Also living in the home was S. A. Nichols, age 45, keeping house, her son, S. T. Nichols, age 10, and her daughter, M. B. Nichols, age 7 years old. The real estate belonged to S. A. Nichols and was valued at \$800. Her personal property was valued at \$500.

By 1880, Sarah Nichols was living in the state of Colorado in the home of her youngest daughter, Mary. The 1880 census for Precinct 6, Mountain House, Gilpin County, Colorado listed Jacob A. Burgess, age 27, a farmer and head of the household, his wife, Mary B., age 18, keeping house, a daughter, Edna M., age 4, and a daughter, Nellie B., age 2 years old. Also listed as living in the home was Sarah A. Nichols, age 56, helping to keep house.

Because Sarah was a Civil War Widow, she was able to claim a homestead at Golden Gate Canyon, Gilpin County, Colorado, located just west of Denver. It was in a cabin on this homestead that her two youngest grandchildren were born, Florence Burgess in 1880, and George Burgess about 1883. The homestead was made up of mountainous land, almost impossible to farm, so the family later moved to Salida, Colorado where Jacob Burgess went to work for the Denver and Rio Grande Railroad. The area that was originally her homestead is now part of a state park.

Sarah Nichols continued to live in the home of her daughter. After the death of her father in 1830, Sophronia Pursley inherited an interest in a 100 acre tract located on the waters of Fallen Timber Creek in Barren County, Kentucky, deeded to her father earlier that same year. Nineteen years later, in a deed dated November 1, 1849, Sophronia Pursley, along with her mother, Margaret F. Nichols, and her brother, Joseph W. Nichols, sold 33 and one third acres out of the original 100 acres to her cousin, Philip H. Burch, for the total sum of \$50 cash-in-hand. (Deed Book T, page 545, Barren County Clerk's Office.)

The 1850 U.S. Census for Barren County listed Joseph T. Pursley, age 34, a farmer, with real estate valued at \$200. Also in the household were his wife, Sophronia E., age 27, a son, Jehu C., age 2, and a daughter, Nancy M., age 1 month, and Martha F. Nichols, age 55, born in Virginia. This was Sophronia's mother, Margaret F. Burch Nichols. She was a widow, her husband, Richard Nichols, having died many years earlier. The 1850 Census showed that Sophronia's first cousin, Phillip Burch, a son of Anne Nichols and Robert B. Burch, lived next door on one side, while her aunt, Polly Nichols Pursley, who married Joseph T. Pursley's brother, John, lived on the other side.

In an indenture dated March 20, 1855, Joseph Willis "Nicholds," of Marion County, Iowa, agreed to sell to his brother-in-law, Joseph T. Pursley of Barren County, Kentucky, his interest in the 66 and two thirds acre tract located on Fallen Timber Creek, which was his share of his deceased father's estate. Joseph T. Pursley paid Joseph W. Nicholds the sum of \$150 cash-in-hand. (Deed Book X, page 25.)

In a separate indenture dated April 5, 1855, between Margaret F. Nichols, widow of Richard Nichols, and her son-in-law, Joseph T. Pursley, Margaret F. Nichols agreed to sell her remaining interest in the same 66 acre tract as above, located on Fallen Timber Creek, to Joseph T. Pursley for the sum of \$140 of which \$40 was paid cash-in-hand and the remainder due in three notes of \$33.33 each. The tract was part of the original 100 acres deeded to Richard Nichols on February 24, 1830. (Deed Book X, page 26.) Joseph T. Pursley and his wife, Sophronia, now owned the entire 67 acres outright. Approximately two years later, in a deed dated January 12, 1857, the 67 acres was sold to Sophronia's uncle, Thomas Nichols, for the sum of \$264. (Deed Book 2, page 480.)

The 1860 census for Glasgow, District 1, Barren County, Kentucky listed Jos. T. Pursley, age 44, as head of family and a farmer, his wife, Sophronia E., age 33, a son, Jehu C., age 12, and a daughter, Nancy M., age 10 years. Twenty years later, there were still two children living in the home. The 1880 Barren County census listed Joseph T. Pursley, age 64, a farmer, his wife, Sophronia E., age 58, a son, Jehu, age 31, teaching school, and a son, John W., age 14, a farm laborer.

As a result of an equity suit filed by Joseph T. Pursley, plaintiff, against John J. Pursley and others, defendants, the Barren County Circuit Court, directed the Master Commissioner for the county at the October term in 1870, to sell at public auction two tracts of land situated in Barren County on the waters of Fallen Timber Creek. The land, formerly owned by William Pursley, now deceased, was comprised of one tract containing 85 acres and a second tract containing 50 acres. A public auction was held on November 19, 1870 and S. H. Boles purchased the two tracts for a sum of \$677. An indenture was made, dated December 17, 1870, conveying said land to S. H. Boles from John J. Pursley, Joseph T. Pursley, Amanda Matthews and Anderson Matthews, Virginia Peden and B. S. Peden, William J. Pursley, Mary Burch, Landon Burch, Sarah Nichols and Joseph W. Nichols, J. M. Bailey, A. S. Bailey, Virginia Roberts and Roberts, Julia

Pursley, Rousseay Pursley and Nancy S. Pursley. (Deed Book 7, page 397, Barren County Clerk's Office.)

The following letter was written to Mary Burgess from her Aunt Amanda (Pursley) Matthews in Glasgow, Kentucky, dated 1908:

Mrs. Mary Burgess,

dear neace, I will attempt to ans your kind and welcome letter which came to hand a few days ago and I was so glad to hear from you once more on earth. Your Uncle Anderson was ready to go and begged so to go home. Dear neace, you don't know how I felt when the sad news reached me of your mother's death. To think that my last sister was gone and I the only one left of ten children. But the Lord's will be done concerning us. We should be reconciled to his will. Let it be as it may. When that news reached me your Uncle Anderson was very poorly, but he lived from that time till the twenty third of August. He died in his 96th year and I at that time was in my 80's. I have had a hard spell of the grip and still have it. I had to leave my old home where I had lived so long and go to live with the children. But according to old age and my feelings, I don't expect to be separated from loved ones long, and when we get over there, it will be like your Uncle Anderson said, it will be the happiest time of all, that ever has been, when we meet where we will never part no more. Your mother used to think lots of Aunt Nancy Barbour and Aunt Ann Wood. You spoke of the weather. It has been very unsettled heare, unhealthy, so many sudden changes. I live with your Uncle Anderson's youngest boy, George Matthews. I wood love awful well to see you but that is something I never expect to see. You send me word about your children.

Well, I guess I had better close for this time. When you answer my letter be sure you send my mail to George Matthews, Glasgow, Ky. Box 87.

Willis O'Brian, age 27, a servant, and Sarah Nichols, age 78. (Note: This 1900 census report is the only reference to the daughters, Cora and Carrie Burgess. Today, living descendants of Jacob and Mary Burgess have never before heard of these girls, and there is no one buried in the Salida, Colorado cemetery with their names. Probably they were children of another family who were living in the Burgess household at the time of the 1900 census. Due to the uncertainty, they are not listed on the family group sheets as children of Jacob and Mary Burgess.)

The 1910 census for Fulford Precinct 16, Eagle County, Colorado listed Jacob Burgess, age 58, a gold and silver miner, and head of the household, and his wife, Mary, age 48. The couple had been married for 36 years, and all four of their children were still living.

J. A. BURGESS DIES, D. & R. G. VETERAN AND MINING MAN (from The Salida Mail, Salida, Colorado, February 1, 1916)

"Stricken by paralysis two years ago while engaged in mining in Eagle County; wife died here last September."

Jacob A. Burgess, veteran railroad conductor who worked out of Salida for thirty years until his retirement fifteen years ago, died last Friday after two years illness of paralysis. He had been helpless since stricken with paralysis and two months ago he entered the Red Cross Hospital not as a patient but to spend the balance of his days. His wife died in Salida last September.

Mr. Burgess was a native of Fostoria, Ohio and was 64 years old. After his retirement from railroad service he went to the Fulford district in Eagle County where he had charge of mining property. He retained his membership in the O.R.C. until his death.

Mr. Burgess is survived by two daughters, Mrs. G. F. Snell of Salida, Mrs. R. A. Hester of Atchee and a son, G. W. Burgess of Gilman. Mrs. Hester was unable to reach Salida for the funeral on account of the snow blockage. Mrs. Snell and the son attended. The funeral was held at 2 o'clock Sunday at the Wenz Undertaking Parlors, the Rev. F. F. Beckerman officiating. Interment was in Fairview.

Obituary of EDNA BARLOW (From the Salida Record, Salida, Colorado, August 25, 1911.)

Mrs. Edna Barlow, wife of F. C. Barlow, of Durango, died very suddenly at that place last Tuesday, August 22nd, at the age of 35 years. She was well known in Salida, having spent the greater part of her life here, until seven years ago, when she removed with her husband and children to Durango, where they

have since resided. Remains are being shipped to this city to be interred in Fairview Cemetery tomorrow afternoon at 2:30 o'clock from the Baptist Church. Deceased was a daughter of Mr. and Mrs. J. A. Burgess, now of Fulford, Colo., and was a graduate from the schools of this city.

Besides her parents, she leaves a husband and four sons, a brother, Geo. Burgess of Helena, Montana, and two sisters, Mrs. R. A. Hester of Gunnison and Mrs. G. F. Snell of this city. At the services tomorrow all of these relatives will be present save her brother George.

FORMER CITIZEN DIES IN DURANGO (From the Salida Mail, Salida, Colorado, August 25, 1911.)

Word was received in the city by wire Wednesday at 2:00 a.m. by Mrs. Fred Snell, that her sister, Mrs. Edna Barlow, died in Durango, Tuesday the 22nd. Mrs. Barlow will be remembered as Miss Edna Burgess. She was the daughter of Mr. and Mrs. J. A. Burgess, former Salida residents, who now reside in Fulford, and she was raised in this city and graduated from the high school, and also married here. The news of her death will come as a great shock to the many friends of this estimable lady, who have known her so many years. Mrs. Barlow leaves four children to mourn the loss of their mother, beside a babe but a few days old. The remains will be brought from Durango by the husband, who will be met in Chama today by the sister and father of the deceased, Mrs. Robert Hester and Mr. Burgess. They will also be accompanied there by Mr. Hester.

The relatives arrived in Salida yesterday to be in attendance at the funeral services at 2:30 Saturday afternoon at the Baptist Church. The body will reach here tomorrow and interment made at Fairview Cemetery.

Walters, a Christian Minister in Salida, Chaffee County, Colorado did solemnize the Rites of Matrimony between Frank C. Barlow and Edna M. Burgess in the presence of her parents on July 2, 1902.

The 1910 census for Durango City, La Plata County, Colorado listed Frank C. Barlow, age 33, head of the household and employed as a teamster on an express wagon, his wife, Edna M., age 34, a son, Samuel G., age 4, a son, John F., age 2, and a son, Harry B., age 1 year, 3 months.

Shortly after the 1910 census was enumerated, Edna Barlow gave birth to the couple's fourth child, Alva Carroll Barlow, born on June 1st of that year. However, approximately one year later, on August 22, 1911, Edna Barlow died during the birth of their fifth child in Durango, Colorado. The newborn baby died as well. Their remains were brought from Durango to Salida where they were interred in the Fairview Cemetery. The four surviving young children were taken to be raised by various relatives. An item from the Salida Mail, dated September 1, 1911, mentions this circumstance:

"Mr. and Mrs. J. A. Burgess departed Tuesday night for their home in Fulford, Colorado, taking with them two of the children lately bereaved in the death of their mother, Mrs. Edna Barlow, at Durango. Mr. and Mrs. R. A. Hester of Gunnison adopted the baby and they also left for their home in Gunnison, Tuesday. Sam, the oldest son, has found a home with Fred Snell and wife in Salida, Mrs. Snell being a sister of Mrs. Barlow."

It is known from the 1920 census that the youngest child, Alva Carroll Barlow, was still living with his aunt and uncle, Robert and Florence Hester, who by then resided in Denver, Colorado. Also, the oldest child, Sam Barlow, was evidently sent back east to relatives in New York because the 1920 census for Kingston, Ulster County, New York shows Samuel G. Barlow, age 14, born in Colorado, was living with his aunt and uncle, Benjamin and Albie Chambers. It is believed that Albie Chambers was the sister of Samuel Barlow's father, Frank. According to the newspaper article above, the two boys, John and Harry Barlow, were taken by their grandparents back to Fulford, Colorado after the funeral. However, four years later, by 1915, both of the grandparents were deceased, and it is not known what happened to the boys at that time. In Frank Barlow's obituary, dated March 5, 1935, it mentions that he was survived by three sons: Samuel Barlow of New York, John M. Barlow of Tacoma, Washington, and Carol A. Barlow of LaSalle, Colorado. It is assumed that Harry Barlow must have died before that time.

The 1930 census for Portland, Multnomah County, Oregon showed that Frank C. Barlow, age 54, a widower, was lodging in a rooming house. He was listed as a muck stick artist employed in the construction of concrete buildings.

FRANK C. BARLOW DIED. BROTHER OF MRS. SNELL (from the Salida Mail, Salida, Colorado, March 5, 1935.)

Mrs. G. F. Snell has received word of the death of her brother-in-law, Frank C. Barlow, on February 26, in Portland, Oregon.

Mr. Barlow was 59 years old. He was a former Salidan residing here until twenty years ago, when he and his family moved to Durango, Colo. Mrs. Barlow died in Durango in 1911. He is survived by three sons, Samuel Barlow of New York, John M. Barlow of Tacoma, Washington and Carol A. Barlow of LaSalle, Colorado, two brothers and two sisters residing in Durango and New York.

No particulars of his death were received. It is thought the body will be brought to Salida for burial.

BROTHER-IN-LAW OF MRS. SNELL TO BE BURIED HERE (from the Salida Mail, Salida, Colorado, March 26, 1935.)

The body of Frank P. Barlow, brother-in-law of Mrs. G. F. Snell, who died February 26, in Portland, Oregon, was cremated and the ashes sent to Salida Friday for burial beside his wife. Burial will be the latter part of the week.

Mr. Barlow was born in New York and was fifty-nine years old. He was married to Edna M. Burgess in 1902. Mrs. Barlow died twenty years ago in Durango and was buried here. He is survived by three sons, Samuel Barlow of New York, John Barlow of Washington and Carol Barlow of LaSalle, Colo. and one brother, Fred Barlow of Durango, and three sisters all of New York.

G. F. SNELL IS DEAD AFTER BRIEF ILLNESS (from the Salida Mail, Salida, Colorado, January 13, 1937.)

George Fred Snell, chairman of the board of County Commissioners of Chaffee County, died at 12:30 o'clock today at Red Cross Hospital where he had been a patient for three days. An attack of flu developed into pneumonia and caused death. Mr. Snell was one of Chaffee County's most prominent and most respected citizens. He had served as a member of the city council and later served one term of four years as County Commissioner. After a lapse of eight years, he was again induced to become a candidate for commissioner in 1934, and he had served two years of his four year term.

In his younger days Mr. Snell was an enthusiastic member of the famous Scenic Line Brass Band and later of the Salida Band. He played the trombone and saxophone until an accident cost him several fingers, after which he played the bass horn. Mr. Snell was a member of the Salida Lodge of Elks and of the Modern Woodmen of America and the Woodmen of the World.

He proved himself a capable, efficient and progressive public official both as a city councilman and later as county commissioner. Mr. Snell was born in Ames, Kan., in September 1871. He came to Salida in 1890. His first employment was as a railroad fireman. Later, he entered the plant of the Salida Mail, in the pre-machine days, as a typesetter. A year or two of this and he entered the employ of the Salida Lumber Co., where he remained for many years, taking one year out on a trip to Willapa Harbor. Oregon, where he worked in a shingle mill. It was in the shingle mill that he suffered the loss of part of his fingers.

Mr. Snell was manager in Salida for the Continental Oil Co. for several years. He re-entered the lumber business, and seven years ago opened a new lumber yard, known as the Snell Lumber Co. He was highly successful in this business.

Mr. Snell was married in 1903 to Miss Nellie Burgess, a Salida girl. He is survived by his wife, a son, Walter; a daughter, Mrs. Florence Baker, all of Salida; a brother, Walter Snell of Leadville, and a sister, Mrs. Peter (Nellie) Gratz of Denver. Walter Snell came from Leadville and Mrs. Gratz from Denver to be at his bedside when they heard that pneumonia had set in.

Mr. Snell became ill Thursday. He had suffered a severe attack of pneumonia about eight years ago. Arrangements for the funeral have not been made.

SERVICES FOR G. F. SNELL ARE HELD SATURDAY -- BUSINESS HOUSES AND CITY OFFICES CLOSED DURING FUNERAL (from the Salida Mail, Salida, Colorado, January 18, 1937.)

The Elks Home was crowded Saturday afternoon with the many sorrowing friends of G. F. Snell, who gathered there to pay their final tribute to the memory of one of Salida's leading citizens. Out of respect to Mrs. Snell, Mayor C. M. Ferno issued a proclamation asking all business houses and city offices to close from 2 to 3 o'clock during the services. Mr. Snell was a former member of the city council and at the time of his death was serving as chairman of the board of the county commissioners. The services were conducted by the B. P. O. Elks of which Mr. Snell was a beloved member. There was a profusion of floral offerings. Mrs. F. C. Paine, accompanied at the piano by Mrs. Stella Churchill, sang "Leave It With Him" and "Still With Thee."

The acting pallbearers were John Jay, Arthur Samson, Frank Fehling, John Mundlein, T. A. Nevens and E. E. Smith. The honorary pallbearers were S. L. Tabor of Buena Vista, John Rawlings, C. H. Kelleher, John Manful, Wallace Schoolfielf, H. R. Hodding, N. E. Davenport, Otis Brookshire, and Mills Hutchinson. The funeral procession to Fairview Cemetery was one of the largest in Salida in recent years.

Walter B. Snell, well known Salida businessman, passed away at 6 o'clock Sunday morning of a heart attack. He complained of pains earlier in the morning and had gone to the Rio Grande Hospital to consult a doctor. He passed away shortly after arriving at the hospital. His wife, Lucille, a patient at the hospital since the birth of their son, Walter, Jr. on March 14, collapsed after being informed of her husband's death.

Mr. Snell was born in Salida on October 23, 1910. He attended the schools of the city and was graduated with the class of 1930 of Salida High School.

Following the death of his father, Fred Snell, Jan. 13, 1937, he assumed the manager ship of the Snell Lumber Co. HURON AREA WOMEN DIE IN TWO-CAR COLLISION

Two well-known Central South Dakota women, one from the immediate Huron area, are dead as the result of a two-car automobile collision near Gann Valley Friday afternoon.

Killed in the crash were Mrs. Charles (Lucy V.) Miner, 70, farm woman who lived 11 miles southeast of Huron, and Mrs. H. C. (Mary A.) McCracken, 47, of rural Forestburg. The head-on crash occurred on State Highway 34 three-fourths of a mile east of the junctions of 34 and 45 north of Gann Valley.

Mrs. McCracken, driver of the car, was a business education teacher at Mitchell High School. The two women were en route to the state convention of the Daughters of the American Revolution (DAR) at Lead. Mrs. Minor was regent of the Huron DAR Chapter and Mrs. McCracken held a similar office in the Mitchell Chapter.

The McCracken car, a 1963 model machine, was headed west when it crashed head-on with a 1964 model auto driven by David Norton of Topeka, Kan. Norton was taken to Jerauld County Memorial Hospital at Wessington Springs for examination but later transferred to a hospital in Sioux Falls where he is being treated for head and shoulder injuries.

Also in the McCracken car were her children, Florence and Robert, who were admitted to the Memorial Hospital in Wessington Springs and are being treated for shock and bruises. Both cars were demolished.

The two deaths bring the South Dakota traffic toll for 1964 to 44, nine above the total at this time last year. The two women were also the second and third from the Huron area to meet death in highway accidents this week. Killed Friday about 12 miles west of Huron on U.S. Highway 14 was Clifford Tendeland, 54, of Huron.

Funeral services for Mrs. Minor will be held Monday at the First Presbyterian Church in Huron with the Rev. Albert W. Peters officiating. Burial will be in Riverside cemetery.

Funeral services for Mrs. McCracken are tentatively set for Tuesday afternoon at the Presbyterian Church in Forestburg. Burial will be in Rest Lawn Memory Garden at Huron. The Basham Funeral Home, Woonsocket, is making arrangements.

Mrs. McCracken, the former Mary Elizabeth Burgess, was born May 24, 1917, in Des Moines, Iowa. She lived in Colorado where she attended Colorado Women's College, Denver, two years and was graduated from Drake University, Des Moines. She married Harold C. McCracken in June 1941.

Mrs. McCracken taught at several points in Iowa and the family lived at Gowrie, Iowa, until four years ago when they moved to rural Forestburg. She was in her fourth year teaching at Mitchell High School. She was a member of the Presbyterian Church at Forestburg, DAR Chapter at Mitchell and several teachers' organizations.








